

# **NFPA Annual Meeting Minutes**

February 25, 2025 Tucson, AZ

# I. Welcome, Call to Order

At 8:15 AM Mountain Time by Chair Keith Simons.

#### II. Chair's Welcome

Simons briefly reviewed the agenda for the meeting, including NFPA's financial performance, a report on the activities of the association, and the election of a new Board of Directors for the fiscal year beginning July 1.

He then provided an overview of some of the association's successes during the current fiscal year, including:

- Launching the new Controls, IoT, and Data (CID) membership category.
- Expanding our intelligence-gathering efforts, focusing on tracking the adoption of new technologies.
- Establishing our partnership with iVT EXPO, allowing NFPA members to promote their offerings and providing targeted education to a new audience of OEM engineers across the mobile end markets.
- Growing our Fluid Power Vehicle Challenge, which directly connects undergraduate engineers to the industry through hands-on, real-world design and build projects.

### III. Treasurer's Report

Treasurer Markus Rauchhaus provided a general overview of NFPA and the NFPA Foundation's financial performance during the past year. Both organizations were in a strong financial position.

Measured on a three-year rolling average, which smooths out the fluctuating income the association receives from IFPE and CONEXPO, total annual revenue for the two organizations is about \$4.4 million and total annual expenses are about \$4.1 million.

In the current fiscal year, 51% of revenue was from dues, 13% from conferences, 10% from donations, 9% from trade show partnerships, and the remainder from investments and other income. Also in the current fiscal year, 72% of expenses were for programs within the various areas of strategic initiative and 28% were for the general and administrative needs of the organizations.

NFPA is required to keep \$1.9 million in its reserve fund to protect the association and its core operations in the event of severe financial distress. NFPA's reserves have stayed fairly steady over the last several years, and are now projected to end the current fiscal year at \$6.7 million.
